**Press and Public** 

Prior to the start of the meeting, Mrs Brenda Jackson from Crediton and District Community Transport gave a presentation on the work of the organisation. From the organisations initial beginnings the work has grown substantially, with a variety of services now being provided, serving in excess of 300 passengers per week.

#### 134. Public Question Time

Representations were made concerning planning application 06/00384/OUT (Outline application for the erection of 12 no. apartments on land adjacent to The Lodge, Western Road.

Residents considered the site was already "full"; the redevelopment of the old hospital to provide 37 residential flats had included provision of 39 allocated residential car parking spaces. The site also accommodates the current Hospital, Social Services and NHS Offices, necessitating parking provision for each organisations' respective staff and visitors. The sum of these demands for parking were said to already result in the site struggling to cope with parking demands. It was reported the original plans for the site redevelopment intended the now proposed land for development as an overflow car park for the site, and this was much needed to meet just the current demand.

There was concern that current parking was already impeding access for emergency vehicles.

It was suggested if the land now proposed for development were allocated for an overflow car park it could also serve as a meeting point for the Landscore School "run" Travel Plan.

### 137. Devon In Touch Roadshow

It was recommended that Councillor representation should be present at the roadshow during its visit and suggested a small presentation board of services provided by the Town Council would be of use.

### 138. High Street Seating - Lloyds Bank

Councillors Elizabeth Brown and Haydon attended a site visit with the Town Clerk to review the proposed re-positioning of public seating. The District Council's suggestion to locate the additional bench alongside the existing on the western side was recommended for support, with a request to Chamber of Commerce to not site hanging flower baskets above. Additionally the owners of Lloyds Bank Chambers be requested to install pigeon netting to the buildings facade and to repair the broken rainwater gutter currently spilling on the existing seat.

### 139. Dog Litter Bin

The junction of Beech Park, Long Meadows and Pound Hill was recommended with the precise location decision being left to District Ward members to liaise with refuse collection officers.

#### 140. Landscore Playspace

Owing to four of the six members who attended being absent from the meeting it was agreed to defer the report to Town Council.

#### 141. Local Bus Timetables

Concern was expressed whether adequate passenger capacity would be provided by the proposed Stagecoach 07:52 service from North Tawton Square via Crediton to Exeter Bus Station given it was replacing two existing services.

Additionally it was stated that the First 16:30 Bamstaple to Winkleigh should be extended to Crediton and Exeter at least on Saturdays, to allow a sensible day return trip.

It was recommended Councillor Walter Brown would draft a letter making the above representations.

### 142. Rail Timetable Consultation

The committee recommended that in view of the increase in passenger numbers using this service, it seemed contradictory and short-sighted to downgrade the current level of service on this line. A reduction in the number of trains stopping at rural stations west of Crediton was likely to lead to more road congestion in Crediton from through traffic to Exeter. The reduction from 12 to 11 services stopping at Crediton would also impact current passengers with less frequent trains.
