171. Allotments.

a) Matters raised by tenants.

The clerk gave an update on tenants' concerns on the inclusion of new terms in the tenancy agreement. The clerk was requested to provide figures on the number of unsigned tenancy agreements to the next General Purposes Committee.

b) Moffats Land Allotments.

Quotations for two options to enhance the perimeter fence were considered. It was agreed councillors would inspect the site and report back to the next general purposes committee.

172. Landscore Playspace.

It was agreed to recommend an allocation of £5000 from section 106 funding to the project. It was also agreed to consider further allocations for phase two of the project.

173. Heritage Finger Posts.

It was agreed to install a new finger post to the Town Square at the top of Market Street to be funded from under-spend.

The clerk was requested to contact highways to request the re-instatement of signage to St Saviours Way car park, and to request additional traffic signage to Market St car park and the Town Square.

AGENDA ITEMS (items for discussion and recommendation

174. Best Food Award.

It was recommended to request permission to mount the award plaque in the District Council office public lobby. The clerk was requested to liaise with the building's manager on the exact location and mounting of.

Councillor Pitts agreed to obtain quotations for the production of A4 photographs to all participants to report to council for consideration.

175. Town Square.

a) *Toilets.*

Councillor Haydon reported a condition of the planning permission for the new flats/shops adjacent the Square required the developer to complete the new toilets prior to beneficial occupation of the new flats, and no later than two years from the granting of the planning consent (18/03/07). Design negotiations were on-going and once available the council would be consulted on the proposals, albeit formal planning permission would not be required.

Thanks were expressed for Councillor Haydon's investigations into the matter.

b) Issues.

It was recommended by majority vote that the reversal of the flow of traffic in North Street be reviewed only once it had been in operation for a period of approximately three months, subject to no serious issues arising in the meantime. (Councillor Adams requested his vote against be recorded)

The instability of the step risers were discussed. It was reported the contractors were due on site to carry out further works to resolve this issue.

It was reported that the Square would be incorporated in the town's floral scheme for the summer.

Issues raised about siting of the Farmers Market on the new Square were being dealt with by the District Council. May's market would be the last market at Belle Parade under the current temporary arrangements implemented for the duration of the Square's construction. Further requests to hold the market there would have to be processed through formal channels with appropriate consultation on road closures.

Councillor Way arrived.

176. Police.

A response from the area commander confirming the recruitment of Community Support Officers for Crediton was reported. It was felt necessary to continue to insist on appropriate levels of beat manager allocation to the town.

Thanks were expressed to the council chairman for his work towards addressing the cut in manpower in the town.
