40. Chairman's Announcements

The Council Chairman announced that the DAPC AGM would take place on 30 September. He would attend as the Town Council's representative and stated that if any other members were interested in attending to contact the Clerk. Councillor Pitts agreed to attend the Congregational Church Service of Welcome for the new pastor.

The Annual Floral Crediton presentation of awards would take place in the Council Chamber on Tuesday 12 September; as many councillors as possible were asked to attend.

42. Planning

- b) Recess Decisions
 Decisions made during the recess under delegated authority were noted and are appended.
- c) Planning Applications <u>Councillor Adams arrived.</u>
 Councillors Adams, Harris, Pitts, Taylor and Walter Brown declared prejudicial interests and left the meeting for the duration of discussion on applications 1739/OUT,

1679/FULL, 1819/LBC and 1908/FULL respectively. Comments made in respect of planning applications considered at this meeting are appended.

- d) Planning Applications for week ending 5 September None.
- e) Local Development Framework

The Chairman of the Council provided an update on the new planning system following the well-attended public meeting held on 29 August. The Clerk had circulated explanatory documentation and reminded members that the deadline for responses on the Core Strategy and Statement of Community Involvement was 3 October.

A formal response would be discussed at the Town Council meeting to be held on 19 September.

- f) Notice of Adoption of Local Plan Noted.
- g) Letter from Forward Planning & Conservation Manager Noted.
- h) Supplementary Planning Document (Design Guide) Noted. Members were happy with the draft content and would make further comment when the full document was presented for consultation.
- i) Notifications of Appeal The Clerk was requested to write to the Planning Inspectorate supporting the Planning Authority's objections.
- j) Red Cross Hill Development Brief

The Clerk reported that the production of a brief had been delayed due to difficulties with the negotiating parties. He was asked to obtain an assurance from the Planning Authority that a brief would be produced as agreed and the Town Council consulted.

43. Allotments

a) Matters raised by tenants.

The Clerk reported an anonymous complaint of damage and trespass at the Barnfield site. The Assistant Town Clerk would investigate on his return to work.

- b) Application for Replacement Shed at Exhibition Road site Approved.
- c) Revised Agreement and Tenants' Ballot

The Clerk had circulated the latest statistics on tenancy agreements and ballot results. The Clerk reported that 78% of tenants had signed and returned the revised tenancy agreement. A final letter would be sent out to the remaining 19 tenants providing 28 days notice of termination of tenancy.

Following a 55% return on the recent ballot, 51% of tenants supported the provision of group insurance and the formation of a tenants association. Twelve tenants had agreed to help form a committee. The tenants meeting was very well attended and, despite some initial reservations, the majority of people present strongly supported the setting up of an association.

It was agreed that the Council would facilitate the creation of a tenants association. The Clerk to make all necessary arrangements.

d) Operator Signage

The operator signage was amended to increase the emphasis on security (Tenants Only-No Trespassing instead of Tenants Only-Access Restricted). A member pointed out that "No Trespassing" did not have any legal strength. The Clerk also emphasised the importance of including emergency contact details and site location – following advice from the emergency services. It was agreed to simplify these details and remove "This site is regularly inspected".

AGENDA ITEMS (items for discussion and recommendation)

44. Highways

The Clerk had circulated a copy of the letter from a local resident complaining about parking/traffic problems in Mill Street/East Street. It was recommended that the issue be raised at the forthcoming Police Liaison meeting. The Clerk to copy the letter to the Police and the Highway Authority.

45. Crediton Hospital

The Chairman outlined the current situation and reported that he had spoken to the Chief Executive of Devon Partnership NHS Trust following his recent letter to the Town Council. As previously agreed, the Chairman of the Council read out his draft letter of response for the committee's approval. Two issues were covered; the future use of Boniface Ward and the imposition of car parking charges at the hospital.

The Chairman's letter was recommended for approval with one minor amendment. The Clerk to action.

46. Licensing Applications

The applications were noted. Members raised objections to the proposed extension of opening hours for the Duke of York. It was recommended that the Clerk convey the committee's concerns to the Licensing Authority:

- Careful consideration should be given to the opinions/objections of nearby residents.
- Members were concerned that the proposals could result in a considerable movement from other licensed premises which, under existing arrangements, closed earlier.
- a means of addressing the present lack of sound-proofing should be investigated.

It was further recommended that Standing Orders be amended to incorporate delegated responsibilities on issues relating to Licensing.

47. Review of Polling Stations

It was agreed to recommend that the Old Town Hall be used as a polling station in the place of the Newcombes Resource Centre which was considered a difficult location to access, particularly by the elderly or disabled. All other locations were considered adequate and suitable.

48. Newcombes Meadow/Church Street Safety Barrier

A member outlined the problem and risk to the public. The Clerk reported that the matter had been reported and was being addressed by MDDC. It was recommended that the Clerk continue to monitor the situation and pursue with MDDC.
