11. Devon Local Transport Plan 2006-2011

The Chairman outlined DCC's proposals and emphasised the need to make a formal response. He agreed to prepare a draft letter for approval at the next meeting.

12. Local Authority Byelaws

It was agreed that the Chairman would raise the issue of the short consultation period with the DAPC. Agenda item at next meeting (General Purposes).

13. Blue Plaque Scheme

A update was provided on the design and cost of the plaques which were approved pending clarification on the text.

14. Town Centre Car Park

Councillor Pitts declared a prejudicial interest and left the meeting for this item. Councillors Taylor, Adams and Way declared a personal interest. Following a brief debate it was agreed that efforts should be made to provide suitable town centre parking. It was further agreed to express support for the motion placed on the 24 May MDDC Planning Committee agenda by Councillor David Nation:

"To consider how to ensure that future development in the Crediton area might be limited until solutions to Crediton's traffic and air quality problems have been implemented."

It was also agreed to bring the following MDDC resolution to the attention of committee members, particularly in relation to item (c) below:

Special meeting of the Resources Committee – 24 September 2003.

"RESOLVED that (inter alia):

(a) the east side of the Market Street car park (Scheme C) be released for development to provide a capital receipt to fund the Town Square scheme;

(b) the scheme be progressed, provided it is within the existing budget, supplemented by the additional capital receipt received from the sale of the development site plus an additional £190K; and

(c) should the scheme progress, a full study of parking and traffic management be undertaken by the time the scheme is completed."

The Clerk to write to MDDC Committee Clerk and Chief Executive.

15. Roadside Signage

Concern was expressed at the delay in resolving the issue associated with inappropriate temporary signage. The Clerk reported that action had now been taken by the MDDC Enforcement Officer and a planning application would be submitted for permanent signs.

16. Crediton Hospital Parking Charges

The following motion was approved, the Clerk to action:

"Council strongly objects to the forthcoming introduction of parking charges at Crediton Hospital (in line with Tiverton Hospital), including charging during evenings and weekends."

17. Concessionary Bus Fares

An update and an explanation were provided on the need for concessionary fares for students. It was agreed to request a meeting between representatives from the Town Council, QECC and Stagecoach Buses. Councillor Walter Brown agreed to act as Town Council representative. The Clerk to arrange meeting and ascertain date of next QECC Council meeting.
