211. Meeting Management

To accommodate visiting members of the public, it was agreed that agenda item 19 (Joy Riding) would be advanced before item 9 (Planning).

212. Public Question Time

213. Chairman's & Clerk's Announcements

The Chairman announced that he would be opening the Crediton Area History Society's exhibition at the Old Town Hall on 20 April.

The Town Council would be hosting a reception for the Twinning Association on 7 May at the Old Town Hall. As a consequence, he asked for assistance from councillors at the Farmer's Market on 7 May from 1040 to 1130. Councillor Way agreed to cover.

The Chairman formally thanked the four councillors, who would be standing down following the election, for their efforts over the years.

The Clerk had no announcements to make.

214. Town Council Minutes

The minutes of the Town Council meeting held on 15 March 2011 were received and approved as a correct record.

215. Matters Arising

Councillor Nation arrived.

Minute 200c: following concerns expressed by a councillor, the Clerk provided an explanation and current advice on the appointment of the external auditor.

216. General Purposes Committee Minutes

a) Minutes

The minutes of the General Purposes Committee meeting held on 5 April 2011 were received and noted.

b) Recommendations

The recommendations of the Committee were approved as minuted.

217. Joy Riding

Councillor Downes provided a brief report outlining problems with anti-social/nuisance driving at the Leisure Centre car park (overflow) at Lords Meadow.

Two members of the public (local residents) also provided details of the nuisance caused by these drivers.

It was agreed to ask the appropriate authorities to consider taking the following action:

- Consider stepping up Police involvement
- Consider the placement of warning notices
- Consider closing the entrance to the car park at night
- Consider an engineering solution for the car park (similar to St Saviour's Way)
- Consider the introduction of a byelaw prohibiting any use of the car park other than parking

The matter would also be placed on the agenda for next meeting of the Creedy Local Action Group on 14 May. Councillor Wright, as chairman of the group, agreed to provide an update at the next Council meeting (17 May).

The Clerk to contact the Police and MDDC.

218. Planning

219. Finance

a) Schedule of Accounts

The Schedule of Accounts, numbers 3230 to 3256 totalling £14657.36, was approved.

b) Donation Requests

CHICKS (Country Holidays for Inner City Kids)

It was agreed that the application for grant funding fell outside the Council's criteria. The Clerk to inform.

220. Devon County Council – Library Consultation

The Chairman summarised the request from DCC for feedback on how usage could be maximised within available resources. Councillors and members of the public were encouraged to respond by completing the on-line questionnaire.

The Chairman commended local library staff for their initiative and efforts to create a valuable community asset. The Council had also contributed, financially, to improvement schemes aimed at increasing usage. Full value should be obtained from the recent modernisation by ensuring that the library is kept open for the maximum time.

It was agreed that opening the library until 4pm on Saturday would be beneficial and would increase usage figures. The library should open on Saturdays, even in the context of a possible reduction in service. The Chairman agreed to investigate the usage figures and report at a future meeting.

221. Mid Devon District Council – Air Quality

Councillor Way provided details on the decision by the MDDC Head of Environmental Health to merge the district's air quality management groups.

Whilst it was appreciated that the argument to merge the groups made some sense from a management point of view, it was strongly felt that there was a continuing need for a Crediton group to deal with issues specifically relating to the town.

Councillor Brown's motion was supported with two amendments. It was agreed that the Council should request a meeting, as soon as possible and in Crediton, of the Air Quality Management Steering Group. It was further agreed that the Council should wait for a reply before requesting a meeting with lead officers and the portfolio holder.

The appointment of a replacement Steering Group representative would be made at the Council's Annual General Meeting to be held on 17 May.

222. Community Right to Challenge/Community Right to Buy

Previous discussions indicated a degree of scepticism about the value of these proposals to local communities especially if communities were specifically not allowed to challenge cuts in services under the Right to Buy, defeating the main purpose of supporting local initiative and enterprise.

The five year limitation placed on the Right to Buy asset register was considered inappropriate for certain community assets which might merit permanent listing.

223. GP Christmas Cover

The Council was made aware of two cases where an out of hours service was not available during the Christmas period.

It was agreed that the Clerk should write to the PCT asking for an explanation and obtaining assurances that this would not happen again.

224. Broadband

The Chairman and the Clerk provided a brief update on the current situation and reported that the local MP had asked for a meeting to help progress improvements in the service.

225. DALC County Committee Election

Deferred to Annual General Meeting (17 May).

226. Mid Devon Transport Group

Deferred to Annual General Meeting (17 May).

227. 20 mph Speed Limits

Despite discouraging comments from DCC quoting Department for Transport guidelines on the implementation of 20mph speed limits, councillors considered that the proposal had considerable merit particularly when associated with an East/West cycle route. At the Town Council's request a cycle route along Belle Parade was being planned. Consequently, it was agreed that the Clerk should write to the Highway Authority expressing the Council's views in support of the motion, emphasising the importance of the E/W cycle route in planning a safe corridor through the town.

228. Councillor Reports

a) Milk Link (Councillor Downes)

An update was provided following a recent community meeting. Milk Link had agreed on a course of action, including the appointment of an independent acoustic expert to carry out a study and make recommendations on alleviating current problems. Further meetings with the community would be held. The Environment Agency would continue to monitor the situation to ensure compliance with regulations and the target deadline of the end of July.

b) Youth Service (Councillor Way)

Concern was expressed over the future of the local Youth Service following proposals by DCC to cut staffing levels. Future agenda item when the full implications of the proposals are known.

c) CAHMS Exhibition (Councillor Nation)

It was reported that the new exhibition would open on 20 April. It had been very pleasing to see the Town Mayor and others attend the preview.

229. Administration

a) Standing Orders

The amendments to Standing Order 27, to reflect the Council's previous decision to create a Finance & General Purposes Committee, were approved.

b) Interim Delegation

During the period in the run-up to the election and the first meeting of the new Council, it was agreed to delegate full authority to the Clerk in consultation with the Chairman and Vice Chairman and in accordance with the Council's existing recess policy.

c) Personnel

It was resolved that, in view of the sensitive and confidential nature of the business to be transacted, it is advisable, in the public interest, that the press and public be excluded and instructed to withdraw.
