15. Declarations of Interest.

It was **resolved** to contact Churches Housing Action Team (CHAT) to obtain further information regarding their application, in particular, the number of people in Crediton they have helped. In the meantime, £1,500 would be earmarked for Churches Housing Action Team (CHAT), subject to satisfactory information being received. (Proposed by Cllr Letch)



It was **resolved** to contact Significant Seams CIC to obtain further information regarding their application, in particular, how many people in Crediton will be involved in the project and how they will be working with Crediton Arts Centre. In the meantime, £527 would be earmarked for Significant Seams CIC, subject to satisfactory information being received. (Proposed by Cllr Brookes-Hocking)

It was **resolved** to contact Unite Carers in Mid Devon to obtain further information regarding their application, in particular, the number of carers in Crediton they are providing direct assistance to, the number of members in Crediton receiving their newsletter and the number of volunteers they have in and around Crediton. In the meantime, £1,000 would be earmarked for Unite Carers in Mid Devon, subject to satisfactory information being received. (Proposed by Cllr Brookes-Hocking)

It was **resolved** to refuse the Age Concern application as it does not fit with the Council's grant aid policy. The grant was required to maintain the fabric of the Age Concern building and was not for either revenue expenses towards the continuing provision of the service or, to provide grant aid toward a specific project or the purchase of equipment. In the meantime, £1,500 would be earmarked for Age Concern, subject to receipt of a satisfactory application for grant funding for the 2019-2020 financial year. (Proposed by Cllr Brookes-Hocking)

It was further **resolved** that a grant budget of £25,000 for 2019-2020 would be required, with a further £5,000 being allocated as an earmarked reserve. (Proposed by Cllr Harris)
