157 Declarations of Interest

Cllrs Letch, Downes and Cairney declared that as members of more than one authority, that any views or opinions expressed at the meeting would be provisional and would not prejudice any views expressed at a meeting of another authority.

166 To receive an update on Crediton Neighbourhood Plan and agree any actions.

Cllr Brookes-Hocking confirmed that advice had been received regarding Policy H2 of the Draft Neighbourhood Plan, which had been found to be 'not in conformity with the National Planning Policy Framework and the Local Plan'. The statement of community involvement also needs to be completed.

167 To receive an update from the Climate Change and Sustainability Sub-Committee.

Cllr Brookes-Hocking advised that the Climate Change and Sustainability Event planned for Saturday 15th February 2020 had been cancelled due to adverse weather conditions. To this end, the children's competition had been transferred to the Sustainable Crediton Seed Share event held on Saturday 28th February 2020. The event had been extremely well attended by the public and four Town Councillors were also available at the event for members of the public to talk to. The children's competition had received 19 entries. Councillor Brookes-Hocking felt that it would be appropriate to give every entrant a small gift, such as a sunflower in a terracotta pot. Members felt this was a good idea. It was **resolved** to allocate £40 to purchase a small gift for each competition entrant. (Proposed by Cllr Brookes-Hocking).

Cllr Letch advised that he had recently attended the Devon County Council Overview and Scrutiny South West meeting, where key stakeholders had shared information regarding their actions on Climate Change. It was agreed Cllr Letch would pass this information to Mid Devon District Councillor Mrs Elizabeth Wainwright, who is Cabinet Member for Climate Change

Cllr Brookes-Hocking advised the next big event is on 28th March 2020, between 9.30 am and 1.00 pm, when the Town Council will be hosting the Climate and Ecology Emergency Community Conversation. It was **resolved** for this to be loaded onto the Council's Facebook page as an event in order to get an indication of the number of people interested in attending. (Proposed by Cllr Brookes-Hocking)

Cllr Brookes-Hocking also advised that the clerking of this Committee will need to be revisited in the near future.

168 To discuss the social care provisions in Crediton and agree any actions.

Cllr Brookes-Hocking advised that she had recently visited Chris Parsons at the Crediton Foodbank to find out how things were going. Unfortunately, since the last update provided to the Council,



things have deteriorated week by week. When asked what could be done to improve the situation, it was felt that having a more accessible Citizens Advice service in the town would be a step in the right direction.

Cllr Letch advised that in his capacity as Chairman of Mid Devon District Council's Scrutiny Committee he wished to look at the Citizens Advice service that is provided across the three Mid Devon towns.

Cllr Brookes-Hocking drew Councillors' attention to the minutes of the Town Council's Grants Committee meeting held in February when it had been resolved for her to meet with Unite Carers to gain a better understanding of the service it offers to residents of Crediton.

It was recognised by all Councillors that Crediton is in need of a central hub which can address, amongst other things, the social care needs of the Crediton community.

It was **resolved** for Cllr Brookes-Hocking to meet with representatives of Unite Carers and Citizens advice to gain a better understanding of the services they are providing to residents of Crediton. (Proposed by Cllr Brookes-Hocking)

- To consider the Local Government Boundary Commission for England's public consultation on its draft recommendations for new electoral arrangements for Mid Devon District Council and agree any actions. Councillors had been directed to the link for further information www.lgbce.org.uk prior to the meeting. It was resolved to note the consultation. (Proposed by Cllr Letch)
- To discuss Devon County Council's proposed action to stop up land adjacent 27 Willow Walk, Crediton and agree any action. Further information had been issued with the agenda. It was resolved to ask Devon County Council who owns the land and to object to the proposals as the land should be retained and used for planting and improving biodiversity. (Proposed by Cllr Brookes-Hocking)
