- 123 To receive a report from the Clerk regarding Old Landscore School following a recent meeting with Mr David Bowles, Corporate Asset Manager (Surplus Land & Estate and Property Intelligence) at Devon County Council and agree any actions.** The Clerk provided Councillors with an update on a recent meeting with Mr Bowles. She advised that in the New Year she would be creating a business plan and proposal for the long term use of the building, which would then be presented to Devon County Council for consideration in February 2020 and form the basis for future negotiations. She confirmed that following this process the full and final proposals will be presented to Council for consideration.

- 124 To discuss car parking at Lords Meadow Leisure Centre and to consider lobbying Mid Devon District Council (MDDC) to introduce a parking permit scheme at the car park for the use of Lords Meadow Industrial Estate businesses and their staff.** This item had been requested by Cllr Harris who declared a personal interest as a relation of hers owns a business on Lords Meadow Industrial Estate. Cllr Harris explained that MDDC has introduced a charging structure at the Leisure Centre, which has stopped local businesses and their staff from using the overflow car park. This has created problems as the industrial estate does not have parking facilities. She suggested that MDDC could sell parking permits for the overflow car park, thus providing an income stream for MDDC and providing local businesses and their staff parking facilities. She also suggested that in

the rare occasion when there are events on at the Leisure centre the permit scheme could be suspended for that odd day.

It was **resolved** for the Town Council to write to MDDC to request it introduces a parking permit scheme at the overflow car park at Lords Meadow Leisure Centre. (Proposed by Cllr Harris)

125 To consider whether the Council would like to accept the offer of a business crime prevention assessment for your town. The assessment would be conducted by Andrew Sharman from the South West Business Crime Centre in association with Devon and Cornwall Police’s Business Crime Lead and at no cost to the council. Further information had been issued with the agenda. It was **resolved** to accept the offer of a business crime prevention assessment for the town. (Proposed by Cllr Wyer)

126 To consider whether the Council wishes to join the Rural/Market Towns Group, membership of which costs £130 per annum Further information had been issued with the agenda. It was **resolved** for the Council to join the Rural/Market Towns Group for one year, membership of which costs £130 per annum. The benefits of membership would be reviewed in 2020 to establish whether it is worthwhile i.e. is it delivering on its aims and objectives. (Proposed by Cllr Downes) The Town Clerk was asked to advise the Chamber of Commerce of the initiative.

127 To consider and comment on Mid Devon District Council’s Animal Welfare Licensing Policy. Further information had been issued with the agenda. It was **resolved** to support the policy. The Council felt that animals in Mid Devon should be protected by the best possible licensing scheme. (Proposed by Cllr Brookes-Hocking) Cllr Cairney abstained from voting.

128 To consider which days the Town Council would like to propose for the four free parking days at St Saviours Way car park in 2020, which are offered Mid Devon District Council. The Clerk advised that historically this has been the day of Christmas in Crediton and the three Saturdays in December leading up to Christmas, however, they can be taken any time in the year.

It was **resolved** to request a Saturday in November (date to be confirmed) for the Christmas in Crediton Parade and Lights Switch-On, two Saturdays leading up to Christmas and the remaining day to be left open for now and decided in 2020. (Proposed by Cllr Downes)
