#### **Future Youth Work in Crediton**

## **Background**

For the last three years, the town council has supported secular youth work in Crediton by contributing to the youth work project run by the Methodist church. The youth worker, Lauren, was based at the church until August 2019. She ran twice weekly all-access youth sessions for 10-14 year olds and 15+. With the youth worker at the Methodist church she did detached sessions, as well as working with the primary schools and QE.

#### Currently

During the past few months, the secular youth sessions have been continuing with sessional workers and volunteers. At the same time, the Youth Work Management Group has been reviewing the project in the light of Lauren's final assessment report which identified developing need and suggested a way forward.

#### **Future youth work**

In brief, the project is going to continue to provide open access youth work sessions but with more emphasis on young people's health and well-being and one-to-one sessions for young people in particular need.

Secured funding sources include Crediton Hospital League of Friends, Connect, the Methodist Church and the Town Council.

#### **Proposal**

In order for the project to progress as soon as possible, Crediton Town Council will release the 19-20 budget allocation (£10,500) immediately, with the 20-21 allocation (£10,500) to follow in April 2020.
