97. Presentation by Gordon Morris Ltd

The Managing Director of Gordon Morris Ltd gave a demonstration of various options available for an audio enhancement system for the Chamber to assist those whom have

hearing difficulties. The demonstration included open, public microphones and individual microphones, induction loop and radio microphones and the various transmission media available were discussed. In addition, he described some of the practical limitations of each option as well as the practicalities of using the equipment and common pitfalls encountered. A member of the public with hearing difficulties was invited to comment on the demonstration and remarked how much better he could hear things said in the chamber and stressing the much superior sound quality from radio mikes than the public, open microphones.

98. Public Question Time

It was agreed that questions raised in Public Questions would be dealt with under item, Minute 99, Allotments.

99. Allotments

- a) The Boniface Allotments Association outlined their request for a covered noticeboard at each of the Exhibition Road and Barnfield sites. They requested that if the Committee approved the purchase, the Allotment Association could make the final choice between the options laid out before the Committee. It was noted that the Association was requesting either a smaller oak or a larger softwood board and Members requested that the Assistant Clerk explain the current financial position of the Allotments expenditure. Once it was established that there was sufficient funds earmarked from the previous financial year and budgeted this financial year, it was proposed that funding for the purchase of the larger, 8 X A4 sized oak noticeboard be made. It was agreed to purchase two 8 X A4 oak boards with steel mounting posts, at £660.00 each, for the display of signs and posters for purposes approved of by the Town Council and the Boniface Allotments Association.
- b) The Assistant Town Clerk updated members on the current allotments. No major issues were identified. It was agreed that the Allotments Sub-Committee would conduct site inspections of the allotment on the evening of Friday 11 April 2008.
- c) It was noted that the hedge at the bottom, Southern boundary at Barnfield is becoming overgrown. Some residents of Spinning Path gardens had brought up the issue with a member. It was agreed that the Assistant Town Clerk investigate the issue.

100. Chairman's Announcements and Meeting Management

It was agreed to bring forward the item on the hearing Loop System for the Chamber.

101. Council Chamber Hearing Loop System

The merits of the various options for assistance of those with hearing difficulties were debated. It was agreed that getting the system right for the Chamber was of higher priority than cost alone and that it was generally felt that a radio based solution was probably the best way forward. It was stressed that the solution selected should be optimised for the Council Chamber and not predetermined on the basis of portability. The input of other parties, notably the District Council and Crediton Hamlets Parish Council, were noted and it was agreed that they should be pressed to assist in financing any solution. It was recommended that a specification of the Council's requirement for the Chamber be provided to Gordon Morris Ltd to recommend a preferred solution.

102. General Purposes Committee Minutes

The minutes of the General Purposes Committee meeting of 4 March 2008 were approved and signed by the Chairman as a correct record.

104. Crediton Parking Traffic Order

It was noted that it was inopportune to debate this issue until after the publication of the County Council review of parking. It was therefore agreed to defer this item until the report on parking in Crediton is available and the Assistant Clerk was requested to write to Devon County Council asking that the Traffic Order is delayed until proper consideration can be given to issues raised by the review.

105. Parish Paths Partnership

The Assistant Town Clerk gave an update of the current situation with regards to the Parish Paths Partnership, (P3). It was especially noted that additional grant funding had been awarded this year thus allowing greater flexibility in completing the planned work for this year.

GENERAL PURPOSES (for discussion and recommendation)

106. Stagecoach Route 50

Members expressed disquiet concerning the ongoing issues with Stagecoach bus Route 50. Despite praising Stagecoach for re-instating the Westernlea loop on a limited number of the bus services, it was felt that the needs of the people living in the Westernlea area were not being met. It was also noted that the problems of operating St Lawrence Green bus stop as a terminus point were ongoing. In particular the bus entering the school premises to turn around, the danger to students of buses manoeuvring whilst school coaches are also around and buses observed to actually go around the Westernlea route, without stopping for passengers, just to turn around as the Green was too busy. Members felt that the company was allowing unsafe practises to be used to save money. It was agreed to contact the school in support of their efforts to get the buses to cease using the school's crescent to turn in and to write to Stagecoach, requesting they consider reinstating more of the western extension routes, especially the 3.30 pm service to deconflict the bus and the school coaches.

107. Council Committee and Working Group Membership

A member of the Town Guide Working Group outlined the need for expertise beyond the Town Council to help compile the necessary information for the town guide. It was agreed to contact the Crediton History Society, the Chamber of Commerce, the 2009 Festival Committee and the Photographic Club for their input. It was also agreed that this working group should also include the Town Council's newsletter and the website content, as these require much the same information as the Town Guide. This could be re-tailored to provide the required articles.

108. War Memorial Pigeon Protection Project

The Committee were updated on the completion of the protection of the War Memorial from pigeons. It was stressed that the recent work had not placed any additional financial burden upon the Council.

109. CCTV

Recent communications with the Chamber of Commerce had highlighted issues concerning the future of the CCTV project. It was agreed that little further could be achieved until the Town Clerk delivered his report to Council and that further debate be deferred. The need to stress, again, to third parties that this was now a Town Council project was noted and that this would be restated to those parties.
