## 118. General Purposes Committee Minutes

The Minutes of the Town Council's General Purposes Committee Meeting of 8 April 2008 were approved and signed as a correct record subject to the following addition: *Minute 109:* "It was requested that the original CAMM proposal for CCTV be redistributed to Councillors, especially new Councillors who may not yet have seen it."

# 119. Planning

#### 120. Allotments

- a) An update on the current situation with the allotments was given to the Committee. It was noted that annual rental invoices and newsletters would be going out shortly. Concern was also raised about the overgrown state of the boundary of the Barnfield site and the premises in Spinning Path Gardens.
- b) The last minutes of the Boniface Allotment Association were received and noted.
- c) It was reported that the plot numbering project was completed with the exception of Moffat's Land, but that this would be finished very soon. It was also confirmed that there are surplus materials to make a few new markers if they are required.
- d) None reported.

# 121. Public Payphones

The notification of the intention to remove some BT payphones in the Mid Devon area was received and the removal of the payphones in Crediton on Exhibition Road and at Fordton was noted.

#### 122. Land At Mill Street

The Committee considered that there would be no objection to sale of part of the open space providing the bench seat was retained in its present position and only the land to its rear is sold. It was also strongly felt that a restriction or covenant should be placed upon the land such that it may not be built upon but could only be used as open space, such as parking or garden. It was also recommended that the space should remain open to full public view by the restriction of the height of boundary walls or fences.

# 123. Use of Town Seal By Crediton Climate Act Group

The use of the Town Seal by the Crediton Climate Action Group on their proposed ecoshopping bag was recommended for approval.

# 124. Costain Funding

It was reported to the Committee that the cost of one of the proposed projects, provision of a skatepark was no longer as expensive as originally suggested due to a change in the suggested design. It was also noted that a presentation to the Council had been requested concerning the proposed skatepark. In light of this, it was agreed to defer this item until the presentation was made.

# 125. Cycle Track

It was agreed to defer this item as Councillor Way was due to attend to update the Committee on the progress of cycle path plans.

# 126. Street Naming

It was confirmed that the Town Council is a consultee but not the authority for road names. Mid Devon District Council are the road naming authority. It was also noted that the spur road to the station appears not to have an official name but is commonly known as Station Approach, the name the Station Tearoom uses on it's postal address. It was agreed that MDDC should be informed that the Council recommends the commonly accepted name of Station Approach for this road in the event that the road is formally named. It was also recommended that this name should apply to the road only as far as the proposed bus gate to the rear of the proposed supermarket retail site, but not beyond it, to avoid confusion by implying that general traffic could access the station via this site. It was further recommended that the name Joseph Locke would be suitable to be incorporated into another road on the new development near the station.

Councillor Way entered the meeting.

#### 127. Town Bus Service

The County Council's proposal for a new, three route bus service provided by S106 monies from the new retail development at Wellparks was discussed and Councillor Brown highlighted some of the issues causing concern. Of especial note was the issue of the large areas of the town not served by the new town bus and the proposed frequency the bus is expected to traverse the stretch of Exeter Road westwards from Station Cross, which was felt to be unachievable during busy periods. Councillor Brown laid out some suggestions for addressing these issues and it was agreed that Councillors attending the meeting with Devon County Council on the 21 May 2008 would us these as a basis for pursuing improvements in this town bus service with the County Council Officers.

# 128. Cycle Track and Exeter Road Crossing

- a) The County Councillor gave a report of the progress of a SUSTRANS survey of possible Crediton to Exeter cycle routes. Some of the practical and financial difficulties were outlined, such as the Exe River crossing at, or near, Cowley Bridge. It was noted that Devon County Council are generally keen on cycle paths and are interested in the Crediton to Exeter route. It was agreed that the County Council should be informed of the Town Council's strong support for progressing such a cycle path and that the Crediton Climate Action Group also be informed.
- b) The second issue raised by the Climate Action Group, namely the difficulty and dangers involved in attempting to cross Exeter Road anywhere to the eastwards of it's junction with Park Road, was debated. It was noted that the problems and risks of crossing this road were of especial interest to bus users travelling East who wished to connect with the train service and also that having to wait for a bus at the Station Cross stops was particularly unpleasant. It was recommended that the Highway Authority be requested to review arrangements for pedestrians in this area in light of the forthcoming roadworks associated with the new Wellparks development. Consideration should be given to moving the bus stop out of the narrow part of Exeter Road, installing a pedestrian crossing and the possible use of pedestrian refuge islands, possibly in conjunction with the current traffic right turn, painted refuges in front of the Shell service station. Additional consideration should be given as to the possibility of using the access road between the industrial units currently occupied by Jewson and Creative Furniture to create a pedestrian access to the Station.

- **131.** Members were reminded of the forthcoming Mayor's Annual Reception and requested to respond if they had not already done so.
- 132. The Committee were informed of the incidence of vehicles parking on the corner of Dean Street and Exeter Road, near to Carey's Bistro. This was creating a hazard for both pedestrians and vehicles at this junction. It was noted that whilst MDDC were assuming responsibility for parking enforcement imminently, not all their officers had completed the necessary training and thus the impact upon illegal parking would be limited for approximately a month.

The current situation with regard to updating and recommissioning the Council's website was reported to the Committee. It was noted that staff had experience of running websites and had helped to set up and maintain the Council's, but, currently, time and the specialist knowledge were no longer available within the resources provided by the Council. It was explained that much time and effort had been expended on getting local, reasonably priced suppliers to carry out the work but that of the five original approaches made, only one was now able to undertake this project and that any delay in commissioning them to start may endanger the price in the quotation presented to members. After some debate, it was recommended that the Clerk be asked to continue discussions with the supplier to recommission, improve and maintain the website for the best price achievable.
