17. Declarations of Interest

18. Elect Chairman

Councillor Harris was elected as Chairman of the General Purposes Committee. Councillor Harris took the Chair.

Mr M Szarbo asked the Council to consider landscaping the western entrance to the town with the Tesco community project funding, including terracing the banks and replanting trees and shrubs.

21. Chairman's & Clerk's Announcements and Meeting Management

The Chairman had no announcements to make.

The Council Chairman reported that he was unable to attend the Mid Devon Show as the Council's representative, and neither could the Vice-Chairman and asked if anybody else wished to attend in their stead. The council Chairman also reported his activities over the recent weeks and that he would be out of contact until 26 July 2009.

The Clerk had no announcements to make.

22. General Purposes Committee Minutes

The minutes of the General Purposes Committee meeting held on 9 June 2009 were received and approved as a correct record.

23. Allotments

a) Allotment Update

The Clerk reported that vacancies arising were being filled by the Boniface Allotment Association but that it had not been possible recently to visit or inspect the allotments due to the pressures on staff.

b) Matters Raised By Tenants

The Secretary of the Allotment Association raised a number of issues, namely; the tap by the north side boundary had been leaking, that the Womens' Environmental Network appeared to be advertising public events on the allotments, and that the Allotment Association had passed suggestions for amendments to the tenancy agreement to the Assistant Town Clerk.

Councillor Wright reported that the Police would prefer allotment holders to park in the road, rather than partially on the pavement on Exhibition Road, as this not only slows the traffic but also prevents obstructing the pavement.

The Council Chairman reported from the judging of the allotments for the Floral Crediton Competition that one allotment in each of Moffat's Land and at Exhibition Road appeared uncultivated and that there had been rubbish dumped near the gate at Exhibition Road.

The new tenancy agreement proposal was deferred until Town Council meeting of 28 TC July 2009.

Crediton History Society, museum set up proposal.

It was agreed, in accordance with the delegated powers of the Council Meeting of 23 June 2009 that a donation of one thousand pounds would be made to the Museum and that the Finance Committee should consider budgeting for future ongoing support donations. It was also noted that the County Council Ward Member could investigate applying for Community Enhancement funding.

26. Licensing

The White Swan application for variation of the licence conditions was objected to on the grounds of late night noise and nuisance very close to neighbouring residences.

27. Town Plan Item

Councillor Brookes-Hocking raised the concerns that development is a major issue within the town, especially with a number of major development projects currently under way or under consideration and expressed concern that progress was very slow. It was noted that much effort had been put into the project by several Councillors and the development of a plan had progressed far beyond anything previously achieved. It was suggested that Councillors may have to have a dedicated meeting to ensure continuing

progress and that the plan may have to be reviewed annually prior to the budgeting exercise.
