91. Apologies

Apologies were received from Councillors Letch (personal), Brown (Council business) and Connell (ill health). In accordance with Standing Order 29, written notice had been received from Councillor Brown appointing Councillor Nation as his substitute for the meeting.

93. Presentation by MDDC Environmental Health Officers

The Lead Officer for Environmental Protection provided an update and information on Air Quality in Crediton (presentation notes appended). The MDDC Environmental Health Manager continued by providing a progress report, highlighting the successful and not so successful aspects of the Air Quality Management Plan:

- low emissions and planning policies were being developed
- expected reductions in emissions through improvements in public transport town bus services
- smoke free and warm zone grants
- working with local businesses to reduce vehicle and industrial emissions
- increased take-up of bus passes
- investigating and implementing latest emission standards
- · difficulties and delays with proposed link road
- difficulties in implementing traffic management practices

There was an increased need to look at changes and ways of moving forward including ways of informing the developing local transport plan (LTP3) with fresh impetus and action. The Steering Group meets on a 3 monthly cycle and would welcome any ideas or initiatives from the local community, including the Town Council.

Councillors Squires (MDDC), Downes and Adams arrived.

Following the presentation, it was agreed that the specific agenda item on this subject be brought forward to facilitate discussion, permit questions and give MDDC officers an opportunity to leave.

94. Air Quality (for discussion and recommendation)

Brought forward agenda item 11.

Councillor Squires (MDDC) left the meeting.

MDDC officers answered questions from members detailing some of the points covered in the presentation:

- importance of the link road and traffic management issues in the reduction of pollutants
- strategic importance of influencing LTP3 (Local Transport Plan)
- importance of disseminating information and encouraging local interest

The officers would be delighted to accept an invitation from the Council to attend an exhibition at the Annual Town Meeting.

a) Clerk's Report

Two vacancies recently filled. Currently no vacant plots. Approximately 50 people on combined waiting lists.

It was agreed that Councillor Adams would turn on the water supply once the risk of frost had reduced.

Councillor Adams agreed to investigate and report to the next meeting (GP).

2. Plot 12 Exhibition Road

It was agreed to transfer ownership as requested.

101. Floral Crediton

The Clerk reported that, in view of the urgency, a revised planting scheme (details provided to members) had been submitted to MDDC and the plant suppliers. With the Chairman's support, a slightly reduced planting scheme had been arranged to accommodate the reduction in the annual allocation. However, careful management in the previous year had resulted in a small surplus which had been used to reduce the impact of the overall cut in expenditure for this item.

It was agreed that a meeting of the Floral Crediton Working Group would be arranged to advise on the positioning of planters for this year and start preparation for the next season.

106. Peoples Park Road Pavement

Following a letter from a local resident, it was agreed that, despite sympathising with the problems, very little of constructive (cost effective) use could be done to alleviate the situation due to the topography of Peoples Park and the constricted road layout. The matter was primarily an issue for the Highway Authority and the Clerk was asked to forward the letter to the appropriate officer. In the meantime, it was hoped that the recently reconvened Peoples Park & Scout Memorial Gardens Working Group would look again at the issue of accessibility.

107. Town Council Insurance

The Clerk reported on the need to increase the Fidelity Guarantee Insurance – an important element of the Town Council's insurance policy. Members were supplied with a completed copy of the application form containing the Clerk's recommendation.

It was agreed to recommend that the fidelity guarantee be increase to £115,000, pending receipt of an acceptable quotation. The Clerk to action and report to the next available meeting.

Local Air Quality Management (LAQM)

Mid Devon

- Legal requirement of all local authorities introduced by Environment Act 1995
- Requires LA's to:
 - "...from time to time assess the air quality in its area..."
- Relatively complex cyclical process of on-going review and assessment of outside (ambient) air quality by monitoring, modelling and technical judgement
- Requires seven specific pollutants to be assessed
- Technical Guidance (published by Defra)
- Focus on locations where air quality most likely to be poor and where there is relevant exposure
- Compare concentrations of specific pollutants against national UK Air Quality Objectives

The LAQM Process

- Every three-years complete a thorough review of air quality in the district – all pollutants and potential 'hot-spot' locations (Updating and Screening Assessment – USA)
- Every year in between USA's complete a Progress Report which deals with changes
- Supported by on-going network of air quality monitoring
- If at anytime a risk of exceeding an Air Quality Objective is identified then must carry out a Detailed Assessment
- Detailed Assessment is just that a more detailed analysis of air quality at a specific location to confirm if there is a problem, and then:
- Legally required to declare an Air Quality Management Area (AQMA) and produce an Action Plan containing measures to pursue improvements



LAQM Outcomes in Crediton

- More comprehensive monitoring network for the town commissioned in 2003
- Detailed Assessment completed leading to designation of an Air Quality Management Area which came into effect December 2004
 - -Nitrogen dioxide in the High Street (exceedances of annual mean objective)
 - -Nitrogen dioxide and particulate matter in Exeter Road (exceedances of annual mean objective NO_2 and daily mean objective for PM_{10})


Air Quality Action Plan agreed and published June 2006

- 31 Measures
- -High impact/cost measures include Lords Meadow Link Road and traffic management in High Street
- Developed in conjunction with the Crediton Air Quality Steering Group

Crediton Air Quality Monitoring




- 6 Diffusion Tube locations (managed and bias adjusted to national standards)

Crediton Nitrogen Dioxide






Average concentrations are 14% above objective (limit value)

On average there are twice the permitted no. of days >50 ug.m³






Pollution Sources

Transport sources=87%




PM₁₀ (Exeter Rd)



- Government estimates that there are <u>24,000 premature deaths</u> each year from poor air quality in the UK compared to 2538 deaths in road accidents
- Based on the UK population means that the UK air quality has an approximate <u>hazard rate of 0.04%</u> (greater than passive smoking)
- Based on a Crediton population of approx 7400 then this could mean a possible 3 deaths per year in town from air quality?
- Possibly an under-estimate for Crediton since an estimated 457 people live along the High Street and Exeter Road frontage where pollution levels are above average
- Elevated concentrations of nitrogen dioxide (NO₂) are associated with inflammed airways, increased risk of respiratory infection and reduced lung function






- Elevated concentrations of particulates (PM₁₀) are associated with respiratory irritation, reduced lung function and can especially impact those with existing heart and lung/respiratory conditions
- Also evidence emerging that particulates can cause specific heart disease in addition to mild cognitive impairment
- Unlike NO₂, particulates are considered to be a non-threshold pollutant – benefits in reducing the concentrations as low as is possible
- Yet despite the differences between air quality and road death figures, the Government spends about 10x more on preventing road fatalities than improving air quality
