#### 181. Public Question Time

The Chairman introduced PCSO David Pilling. PCSO Pilling provided an update on local Police issues. He reported a very good Christmas and New Year period with few incidents. The sector inspector had announced an increase in staff resources. Two new beat managers will be employed in rural Crediton. A fourth PCSO will be employed in Crediton, bringing total staffing levels to three beat managers and four PCSO's.

PCSO Pilling answered questions from members relating to parking offences, litter and anti-social behaviour.

It was suggested that detailed discussion of individual problems would be dealt with at the forthcoming Police Liaison meeting.

The Chairman thanked PCSO Pilling for taking the time to attend the meeting and providing valuable information.

There was no further public participation.

#### 182. Chairman's Announcements

The Chairman invited the Chairman of the General Purposes Committee to comment. The GP Chairman expressed his concern over the large number of agenda items for Council compared with items for the General Purposes Committee. The Clerk explained that the period up to and beyond the Christmas period had been difficult, particularly since the January GP meeting had been replaced by the Finance Committee meeting. The submission of items was also largely dependent on members who continued to express a preference for debate at full Council.

The Chairman had no announcements to make.

The Clerk left the chamber for the duration of the debate on application 08/00006/MFUL.

d) DCC Consultation on Validation of Planning Applications Noted.

e) Red Hill Cross Pre-application Consultation

Members who attended the pre-application exhibition held on 17 January provided a brief report.

It was agreed that the Clerk should contact the consultants to arrange for the public exhibition material to be made available to councillors.

f) Rescission of Decision on Application 07/02064/ARM

Written notice to rescind the decision of the General Purposes Committee in relation to application 07/02064/ARM had been received by the Clerk, in accordance with Standing Order 20.

It was further agreed that the previous comment should be replaced with:

"OBJECTION - because of the disproportionate impact on the amenities of properties immediately below in Park Street – the development should be restricted to two storeys. The height of the building, and of its highest windows, should be limited to those of the approved Outline permission. Drainage should be controlled as already specified in conditions with the Outline permission."

#### 189. Finance

Councillor Way arrived.

a) Schedule of Accounts

The schedule of accounts, numbers 002748 to 002763 amounting to £7681.74 was approved. Councillor Adams requested that his vote against approval be recorded.

The Clerk explained that, due to the Christmas period, payment for two months printer costs were included.

Councillor Adams queried the costs of providing a pigeon deterrent at the War Memorial. The Clerk explained that there was a continuing problem that needed to be addressed. Additional deterrent work had been agreed and carried out largely within the existing contract. Additional work (conservation) had been identified and agreed for completion at a previous meeting. The Council had accepted the lowest quotation for pigeon deterrence which was considerably less than the nearest alternative.

b) Finance Committee Minutes

The minutes of the Finance Committee meeting held on 8 January 2008 were received and noted.

c) Finance Committee Recommendations, Budget & Precept 2008-9

Councillors Brown, Downes and Wright stated that they would leave the meeting if any discussions occurred relating to an item under 6.4 of the minutes (Crediton Community Transport). No discussion took place.

The recommendations of the Finance Committee held on 8 January 2008 were approved.

Additionally, on the recommendation of the Finance Committee, the Council was asked to make a final decision on the following budget items:

Hearing Loop System

It was agreed to make no specific allocation but obtain further information and request a presentation from the preferred contractor. If considered appropriate, funds would be taken from underspend reserves to cover the costs of installation.

Reserves

It was agreed to reduce the estimated contingency reserves to the basic 13 week requirement; the saving to be used to subsidise the proposed precept.

Underspend reserves would be earmarked for use by projects to include:

- Refurbishment of the Scout Memorial Gardens at Peoples Park
- Hearing Loop System
- Proposed improvements to the Lords Meadow Skate Park

Consequently, a formal motion to approve the report and the recommendations of the Finance Committee meeting held on 8 January 2008 was carried, setting a precept of £93928 for the financial year 2008/9 with a total budget of £97712 (£3784 to come from contingency reserves).

Councillor Adams requested that his vote against be recorded.

#### 192. Town Councillor Vacancy

Applications had been received from two candidates. Following a secret ballot, Mrs Anne Hughes was appointed to fill the vacancy in Boniface ward.

# 193. Newcombes Meadow Lighting

Two councillors provided an explanation and update on the requirements and suitable options. It was agreed that the Council should enter into discussions with MDDC to explore the possibilities for the installation and funding of a solar powered light at Newcombes Meadow to supplement the present inadequate coverage.

#### 194. Town Guide

The small working group of two councillors set up to investigate the possibility of producing a town guide provided a short report. It was agreed to progress the feasibility of proceeding in consultation with the approved consultant – Local Authority Publishing.

### 195. Devon & Somerset Fire & Rescue Consultation

The consultation document was noted but the Clerk was asked to convey, in his response, the importance of maintaining full staffing levels and the continuity of current services at Crediton.

#### 196. Code of Conduct – Consultation Document

The consultation document detailing the proposed changes to the Members' Code of Conduct was noted and recognised as an important improvement.

#### 197. CCTV

a) CCTV Group Minutes – 10 December 2007
 Noted.

b) Update

It was confirmed that there were no plans to monitor the system locally. This would be done from the Tiverton Control Centre.

No further progress had been made with the completion of the installation.

#### 198. Town Council Representative

Councillor Nation was nominated and appointed as the Council's representative on the Crediton Fairtrade Partnership.

#### 199. Stagecoach 50 Service

It was reported that there were continuing objections and concerns expressed by local residents about the withdrawal of the service to Westernlea.

It was agreed that the Clerk should write in support of the request to provide additional buses to Westernlea at key times – two buses between 0900 and 1100 and one at approximately 1500 Monday to Friday. It was also reported that buses are currently wasting 10-15 minutes at the St Lawrence Green terminus when they could be accepting passengers.

#### 200. Bus Passenger Consultation Body

The consultation document on options for strengthening bus passenger representation was noted. It was agreed that it would be sensible to stress the need for an effective body

which would be set up with sufficient resources and power to act and which would not be stifled by red tape or prevented from doing what might be needed.

#### 201. Prosecution of Contractors

Recent incidents of delay were reported. It was agreed to ask the Highway Authority to prosecute in every verified future incident involving the use of traffic lights on the A377 from Crediton High Street to Cowley Bridge and to inform the Council, in advance, when the use of traffic lights is authorised.
